### An Exciting Camp Experience Especially Designed For Those Going Into The 4th-6th grades

Camp Impact takes place on the beautiful campus of Oklahoma Christian University in Oklahoma City, Oklahoma. Camp Impact is all the fun and experiences of summer camp and much, much more! From start to finish, campers see, hear and demonstrate what it means to allow JESUS to IMPACT their life. They leave with an incredible IMAGE of CHRIST in their minds. They come home ready to make an IMPACT on the world.

#### Housing & Facilities

Impact campers will be housed in air-conditioned dorm rooms on OC's campus. Our students may sleep in a twin size bed or on a twin size foam pad provided. Not all mattresses in rooms will have frames. Meals will be provided through the campus cafeteria. Activities will be held on and near the campus.

#### Roommates

Please give your roommate request to your group sponsor or Children's Minister/Youth Minister. They will be making your group rooming assignments.

#### Registration & Cost

Camp Impact is for those going into the 4th-6th grades. Cost of camp is \$200 per student. (Early-bird fee \$180 per person if postmarked by May 2 2010.) Fee includes... lodging, meals, snacks, t-shirt and supplies.

#### Check-In

Check-in will be from 3:30-5:00 p.m. on Sunday. No early arrivals.

#### Check-Out

Camp concludes on Thursday at 10:00 a.m. We will check out as groups. All visitors to our campus before 10:00 a.m. must check in at Impact Central.

#### Counselors/Staff

Camp Impact maintains a 5-to-1 camper to staff ratio. Counselors include adult volunteers, college students and a specially selected group of high school students.

#### What To Bring

Sleeping bag or bedding, personal items, towels, Bible, notebook, pencil, swimsuit, modest clothing, etc...

#### Do Not Bring:

CD players, video games, ipods, laptops, electronic equipment, etc. Cell phones are not allowed.

#### Dress & Conduct

Students are expected to dress and conduct themselves in appropriate manners. Modest clothing must be worn at all times. Students are expected to follow all camp guidelines which are posted on our website at [www.campoc.org](http://www.campoc.org).

#### Closed Camp

To enhance the camper's experience we do not allow checking in and checking out of camp. Students cannot be checked out for visits, sports events, etc. When registering, please plan on staying for the full session of camp. Students who check out early will not be allowed to return to camp during this session.

Students are expected to comply with all camp rules and guidelines. Failure to comply with rules and guidelines is grounds for immediate dismissal from camp. No refunds or credits will be given for dismissal. Guidelines are posted at [www.campoc.org](http://www.campoc.org).

#### Special Needs Campers

We want every student possible to have the best experiences of Camp Impact. Parents who have special needs campers should **inform us in writing prior to camp**. This will help us better minister to your child. We ask that you understand that we use a completely volunteer staff and there are situations in which we may not be able to accommodate a student unless further assistance is provided by their parent(s) on site.

#### Camp Visitors

All visitors to camp must check in at IMPACT CENTRAL which is marked by CAMP IMPACT signs from the main campus entrance. No visitors under 18 years of age are allowed without an adult sponsor. All visitors must wear proper ID and comply with visiting hours. No visitors are allowed in residence portions of the dorms at any time. DO NOT visit campus during meal times.

We discourage frequent visits to campus from parents or siblings during the camp week. For your child's maximum camp experience, please let them be at camp without distractions. See more about our visiting hours and policies at [www.campoc.org](http://www.campoc.org).
